It signifies that the Race Director has completed a thorough review of an event's swim, bike and run courses, has evaluated and planned for medical, emergency, safety and volunteer support, and that the Race Director will conduct the event according to the rules and regulations governed by the World Triathlon (WT), Triathlon Canada and/or Triathlon BC.

Due to the changing climate in our province and across the world, Triathlon BC's policies governing environment-related conditions are under review, and may be updated in the 2025 Sanction Package, continuing our emphasis on participant safety.

The information supplied below will appear on the Triathlon BC website race calendar, please double check all information for accuracy.

- Events that do not have a recent Triathlon BC sanction history are required to submit a letter of endorsement, issued by the host municipality they wish to run an event in. Each letter must indicate the name of the organizer, proposed date and location of the event, and be signed by the permit issuing department of the host community.
- All outstanding fees must be resolved prior to submitting a Race Information Sheet for the comings season. Events
  with outstanding event fees will not be candidates for sanctioning and will not be provided with insurance
  coverage.

Triathlon BC is part of Triathlon Canada's National Triathlon Registration System (NTRS), a common database shared

with triathlon governing bodies across Canada, allowing for immediate membership verification - and day membership purchase. Based out of North Vancouver, the NTRS also handles event registration needs, and offers a high degree of quantitative analysis to its clients.
